



S.A.F.E. Adoption Agreement

The following information is to be read, understood, agreed to and signed by the adopting party. No animal will be released until this document is signed and payment in full has been received.

- ◆ The listed animal must be de-sexed (if not already) at the age of six (6) months OR within two (2) months of adopting.
- ◆ Dogs need to have continuous, current registration with your Shire, as required by law.
- ◆ The listed animal must wear their S.A.F.E. tag, an ID tag with the Owner's contact details and the Shire registration tag (if a dog). The listed animal is also required to be micro chipped if not already OR have the owner's information updated.
- ◆ The below mentioned animal must have continuous vaccinations and worming treatments, along with ear mite and tick treatments or any other parasite treatments that may be required.
- ◆ In the case of illness or accident, the owner will ensure the animal receives suitable veterinary care at the owner's expense.
- ◆ The below mentioned animal will be regularly provided with adequate water, food and exercise, as well as being provided with a safe and healthy environment.
- ◆ The below mentioned animal may not be bred from, rehomed, sold, leased, or disposed of without the written consent of **S.A.F.E.**

If at anytime I/We (**being the new owner/s**) of the below mentioned animal can no longer provide appropriate care for the listed animal for any reason, OR if **S.A.F.E.** believes the animal is being neglected, ill treated or that any of the above requirements have not been adhered to, then **S.A.F.E.** will revoke the adoption agreement and the below mentioned animal will be reclaimed into the care of **S.A.F.E.**

Once document has been signed all conditions of adoption are active immediately.
